**THE SHAH ABDUL LATIF UNIVERSITY ACT, 1986  
SINDH ACT NO.XI OF 1986**

	<p>(First published after having received the assent of the Governor of Sindh in the Gazette of Sindh (Extra-Ordinary) dated: 8th December, 1986).</p> <p style="text-align: center;"><b>AN ACT</b></p> <p>to establish <i>Shah Abdul Latif University</i> at Khairpur.</p> <p>Whereas it is expedient to establish Shah Abdul Latif University at Khairpur: It is hereby enacted as follows:-</p> <p style="text-align: center;"><b>CHAPTER - I PRELIMINARY</b></p> <p>1. (1) This Act may be called the Shah Abdul Latif University Act, 1986.</p> <p>(2) It shall come into force on such date as Government may, by notification in the official Gazette, appoint.</p>	<p><b>Preamble</b></p>
<p><b>Definitions</b></p>	<p>2. In this Act unless there is anything repugnant in the subject or context:</p> <p>(a) "Academic Council" means the Academic Council of the University;</p> <p>(b) "Affiliated College" means an educational institution affiliated to the University but not maintained or administered by it;</p> <p>(c) "Authority" means any of the Authorities of the University specified in section 20;</p> <p>(d) "Chancellor" means the Chancellor of the University;</p> <p>(e) "College" means a constituent college or an affiliated college;</p> <p>(f) "Constituent College" means a college maintained and administered by the University;</p> <p>(g) "Dean" means the Chairman of the Board of a Faculty;</p> <p>(h) "Director" means the head of a Teaching Division or an Institute established as a constituent institution by the University;</p>	<p><b>Short title and commencement</b></p>

- (i) "Educational Institution" means an institution imparting instruction in a subject or subjects relating to a Faculty;
- (j) "Faculty" means a Faculty of the University;
- (k) "Government" means the Government of Sindh;
- (l) "Prescribed" means prescribed by Statutes, Regulations or Rules;
- (m) "Principal" means the head of a College;
- (n) "Professional College" means a college providing for instruction in courses of study leading to a degree in medicine, commerce, education, law, fine arts or such other subjects as may be prescribed by Regulations to be professional subjects;
- (o) "Pro-Vice Chancellor" means the Pro-Vice Chancellor of the University;
- (p) "Registered graduate" means;
- (i) a graduate of the University who has his name entered in the register maintained for this purpose, or
- (ii) a graduate of any other University who ordinarily resides within the territorial jurisdiction of the University and has his name entered in the register maintained by the University for this purpose;
- (q) "Research Officer" means a person engaged whole-time by the University for research and equivalent in rank to a University Teacher;
- (r) "Senate" means the Senate of the University;
- (s) "Statutes, Regulations and Rules" means respectively, the Statutes, the Regulations and the Rules made or deemed to have been made under this Act and for the time being in force;
- (t) "Syndicate" means the Syndicate of the University;
- (u) "Teachers" include Professors, Associate Professors, Assistant Professors and Lecturers engaged whole-time by the University or by the College for teaching degree, honours or post-graduate classes, and such other persons as may be declared to be Teachers by Regulations;
- (v) "Teaching Department" means a teaching department maintained and administered, or recognized by the University;
- (w) "University" means the Shah Abdul Latif University, as constituted under this Act;

- (x) "University Teacher" means a whole-time Teacher appointed and paid by the University, or recognized by the University as such; and
- (y) "Vice Chancellor" means the Vice Chancellor of the University;

**CHAPTER--II  
THE UNIVERSITY**

3. (1) The Shah Abdul Latif University shall be constituted at Khairpur in accordance with the provisions of this Act.

(2) The University shall consist of-

- (i) The Chancellor, the Pro-Chancellor, the Vice Chancellor, the Deans, the Principals, the Directors, the Chairman of Teaching Departments, the Registrar, the Director Finance, the Controller of Examinations, Resident Auditor, Chief Accountant, Bursar, Director Planning, Project Director, Inspector Colleges, the Librarian, and such other officers as may be prescribed;
- (ii) The members of the Senate, the Syndicate, Academic Council & other Authorities of the University;
- (iii) All University Teachers; and
- (iv) Emeritus Professors;

(3) The University shall be a body corporate by the name of the Shah Abdul Latif University and shall have perpetual succession and a common seal, and may sue and be sued by the said name.

(4) The University shall be competent to acquire and hold property, both movable and immovable and to lease, sell or otherwise transfer any movable or immovable property vested in or acquired by it.

(5) All properties, rights and interests of whatever kind, used, enjoyed, possessed owned or vested in or held in trust by or for the additional Campus of the University of Sindh at Khairpur and all liabilities legally subsisting against that campus shall pass to the University.

4. The University shall have the powers-

- (a) To provide for instruction in such branches of learning as it may deem fit, and to make provision for research and for

	<p>the advancement and dissemination of knowledge in such manner as it may determine;</p> <p>(b) To prescribe courses of studies to be conducted by it and the colleges;</p> <p>(c) To hold examinations and to award and confer degrees, diplomas, certificates and other academic distinctions to and on persons who have been admitted to and have passed its examinations under prescribed conditions;</p> <p>(d) To confer honorary degrees or other distinctions on approved persons in the manner prescribed;</p> <p>(e) To provide for such instructions for persons not being students of the University as it may determine, and to grant certificates and diplomas to such persons;</p> <p>(f) To confer degrees on persons who have carried on independent research under prescribed conditions;</p> <p>(g) To affiliate and disaffiliate educational institutions under prescribed conditions;</p> <p>(h) To admit educational institutions to its privileges and to withdraw such privileges under prescribed conditions;</p> <p>(i) to inspect colleges and other educational institutions associated or seeking association with it;</p> <p>(j) To accept the examinations passed and the periods of study spent by students of the University at other Universities and places of learning as equivalent to such examinations and periods of study in the University, as it may determine and to withdraw such acceptance;</p> <p>(k) To co-operate with other Universities and public authorities in such manner and for such purposes as it may determine;</p> <p>(l) To institute professorships. Associate Professorships. Assistant Professorships and Lectureships. and any other posts and to appoint persons thereto;</p> <p>(m) To create posts for research. Extension, administration and other related purposes and to appoint persons there to;</p> <p>(n) To recognize selected members of the teaching staff of affiliated colleges and colleges or educational institutions admitted to the privileges of the University or such other persons as it may deem fit as University Teachers;</p> <p>(o) To institute and award fellowships. Scholarships. exhibitions, bursaries, medals and prizes under prescribed conditions;</p> <p>(p) To establish Teaching Departments. Schools. Colleges. Faculties. Institutes. Museums and other centres of learning for the development of teaching and research and to make such arrangements for their maintenance. management and administration as it may determine;</p>

<p><b>Jurisdiction of the University</b></p>	<p>(q) To control the residence of the students of the University and the Colleges to institute and maintain halls of residence and to approve or license hostels and lodging;</p> <p>(r) To supervise and control the discipline of the students of the University and the colleges to promote the extra-curricular and recreational activities of such students. and to make arrangements for promoting their health and general welfares;</p> <p>(s) To form union of the students in the prescribed manner;</p> <p>(t) To demand and receive such fees and other charges as it may determine;</p> <p>(u) To make provision for research and advisory services and with these objects to enter into arrangements with other institutions or with public bodies under prescribed conditions;</p> <p>(v) To enter into. carry out very or cancel contracts;</p> <p>(w) To receive and manage property transferred and grants, bequests, trusts, gifts, donations, endowments and other contributions made to the University and to invest any fund representing such property, grants, bequests, trusts, gifts, donations, endowments or contributions in such manner as it may deem fit;</p> <p>(x) To provide for the printing and publication of research and other works; and</p> <p>(y) to do all such other acts and things, whether incidental to the powers aforesaid or not, as may be requisite in order to further the objects of the University as a place of education, learning and research;</p> <p>5. (1) The University shall have jurisdiction within the limits of its Campus and in respect of all colleges in such areas within Sukkur Division as may be notified by Government.  Provided that Government may, in consultation with the University, by general or special order, modify the jurisdiction.</p> <p>(2) No educational institution situated within the territorial limits of the University shall, save with the consent of the University and the sanction of Government, be associated in any way with, or seek admission to the privileges of any other University.</p> <p>(3) The University may admit to its privileges under prescribed conditions, an educational institution falling within the territorial limits of another University, whether inside or outside Pakistan, provided the consent of such other University is first obtained.</p>

The University shall be open to all persons of either sex and of whatever religion race creed class or colour and no person shall be denied the privileges of the University on the grounds of religion, race, caste, creed, class or colour.</p> <p>Provided that nothing in this section shall be deemed to prevent religious instructions being given to the students in their own religious faiths in such manner as may be prescribed.</p>	
<p>Teaching in the University.</p>	<p>7. All recognized teaching in various courses shall be conducted by the University or the colleges in the prescribed manner and may include lectures, tutorials, discussions, seminars, demonstrations as well as practical work in the laboratories, hospitals, workshops and farms and other methods of instructions.</p>	
<p>Recognized Teaching and courses</p>	<p>8. (1) The authority responsible for organizing recognized teaching shall be such as may be prescribed.</p> <p>(2) The courses and the curricula shall be such as may be prescribed.</p>

(1) The Chancellor may cause an inspection or inquiry to be made in respect of any matter connected with the University, and shall, from time to time, appoint such person or persons as he may deem fit for the purposes of carrying out inspection of –</p> <ul style="list-style-type: none"> <li>(i) the University, its buildings, Laboratories, Libraries, Museums Workshops and Equipment;</li> <li>(ii) any institution, college or hostel maintained or recognized by, or affiliated to the University;</li> <li>(iii) the teaching and other work conducted by the University; and</li> <li>(iv) the conduct of examination held by the University.</li> </ul> <p>(2) The Chancellor shall, in every such case as aforesaid, give notice to the Syndicate of his intention to cause an inspection or inquiry to be made, and the Syndicate shall be entitled to be represented there at.</p> <p>(3) The Chancellor shall communicate to the Syndicate his views with regard to the results of such inspection or inquiry and shall after ascertaining the views thereon of the Syndicate advise the Syndicate on the action to be taken.</p> <p>(4) The Syndicate shall communicate to Chancellor such action, if any, as has been taken or may be proposed to be taken upon the results of the inspection or inquiry. Such communication shall be submitted to the Chancellor within such time as may be specified by the Chancellor.</p>	<p><b>Visitation</b></p>

<p><b>Pro-Chancellor</b></p>	<p>(5) Where the Syndicate does not, within a specified time take action to the satisfaction of the Chancellor, the Chancellor may after considering any explanation furnished or representation made by the Syndicate, issue such directions as he thinks fit, and the Vice Chancellor shall comply with such directions.</p> <p>12. (1) The Minister for Education shall be the Pro-Chancellor.</p> <p>(2) Should the Chancellor be incapacitated from acting as such due to absence or any other cause, the Pro-Chancellor shall exercise all the powers and perform all the duties of the Chancellor.</p>	
<p><b>Vice-Chancellor</b></p>	<p>13. (1) The Vice Chancellor shall be appointed by the Chancellor for Chancellor a period of four years on such terms and conditions as the Chancellor may determine and shall hold office during the pleasure of the Chancellor.</p> <p>(2) At any time when the office of the Vice Chancellor is vacant, or the Vice Chancellor is absent or is unable to perform the functions of his office due to illness or some other cause, the Chancellor shall make such arrangements for the performance of the duties of the Vice Chancellor as he may deem fit.</p>	
<p><b>Powers and duties of the Vice Chancellor</b></p>	<p>14. (1) The Vice Chancellor shall be principal executive and academic officer of the University and shall ensure that the provisions of this Act, the Statutes, the Regulations and the Rules are faithfully observed in order to promote the general efficiency and good order of the University. He shall have all powers necessary for this purpose including administrative control over all officers, teachers and other employees of the University.</p> <p>(2) The Vice Chancellor shall, in the absence of the Chancellor and Pro-Chancellor, preside at the Convocation of the University and the meetings of the Senate and shall, if present, preside at the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside at any meeting of any other Authority or body of the University.</p> <p>(3) The Vice Chancellor may in an emergency which in his opinion, requires immediate action, take such action as he may consider necessary and shall, as soon thereafter as possible, report his action to the officer, authority or other body which in the ordinary course, would have dealt with the matter.</p> <p>(4) The Vice Chancellor shall also have the powers -</p> <ul style="list-style-type: none"> <li>(i) to create and fill temporary posts for a period not exceeding six months;</li> <li>(ii) to sanction all expenditure provided for in the approved budget, and to re-appropriate funds within the same major head of expenditure;</li> <li>(iii) to sanction by re-appropriation an amount not exceeding five thousand rupees for an unforeseen item not provided for in the budget, and report it to the Syndicate at the next meeting;</li> </ul>	

	<p>(iv) to appoint paper setters and examiners for all examinations of the University after receiving panels of names from the relevant authorities;</p> <p>(v) to make such arrangements for the scrutiny of papers, marks and results as he may consider necessary;</p> <p>(vi) to direct teachers, officers and other employees of the University to take up such assignments in connection with teaching, research, examinations, administration and such other activities in the University as he may consider necessary for the purpose of the University;</p> <p>(vii) to delegate subject to such conditions, if any, as may be prescribed, any of his powers under this Act to an officer or officers of the University;</p> <p>(viii) to exercise and perform such other powers and functions as may be prescribed ; and</p> <p>(ix) to make appointments to all posts in any pay scale up-to the BPS-16 or equivalent;</p> <p>15. (1) A Pro-Vice Chancellor may be appointed for a period not exceeding four years at a time by the Chancellor in consultation with the Vice Chancellor on such terms and conditions as Chancellor may determine.</p> <p>(2) The Pro-Vice Chancellor shall notwithstanding anything contained in this Act exercise such powers and perform such functions of the Vice Chancellor or such other powers and functions as the Chancellor may delegate to him.</p> <p>(3) The Pro-Vice Chancellor, if appointed, shall be an ex-officio member of the Senate, Syndicate and Academic Council and shall be deemed to be included in the University under sub-section(2) of section 3 and be an officer of the University under section 9.</p> <p>16. Preamble WHEREAS, it is expedient to amend laws relating to the Universities and other educational Institutes in force in the Province of Sindh, in the manner here in after appearing;

AND WHEREAS, the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteen day of October, 1999, and the Provisional Constitutions order No.1 of 1999;

AND WHEREAS, the Governor of Sindh is satisfied that circumstances exists which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid proclamation and the Provisional Constitutions order read with Provisional Constitutions (Amendment) Order No.9 of 1999, and in exercise

of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

**Short title and commencement**

1 (1) This Ordinance may be called the Sindh Universities and Institutes Laws (Amendment) Ordinance, 2002.

(2) It shall come into force at once
